Québec Marine Industry Economic Impact

A sea of possibilities

Study overview

The St. Lawrence Economic Development Council (SODES), Ministère des Transports du Québec (MTQ) and partners wanted to measure the economic spinoffs of all of Québec's maritime and port activities, a feat last accomplished about fifteen years ago. The analysis focused on both freight and passenger trafic. This study covers the territory served by the St. Lawrence navigation system and its tributaries in Québec.



The SODES is a non-profit organization founded in 1985 and mandated to protect and promote the economic interests of the St. Lawrence maritime community. It represents near hundred of organizations of which the activities are connected in the St. Lawrence.

Definition of industry

The definition of "marine industry" used by SODES and the MTQ includes the entire range of activities of operations (businesses) and organizations involved in the industrial products receiving, expediting and distribution chain and those ensuring passenger transportation in the marine system.

Collection and analysis

The economic spinoffs were calculated using operating expenditures and investments evaluated in 2010 by the operations composing the industry. This information was obtained through a survey of representative sampling of all operations. According to this survey, the industry counted 262 establishments in 2011.



Importance of marine and port activity in Québec

A navigation and port system's scope, or importance, is often described in terms of ship movements, incoming and outgoing tonnage, number of passengers transported, etc. While this study's main goal is to measure the industry's economic contribution, we will, nevertheless, present a few shipping and port-related characteristics.

Economic spinoffs

...of operating expenditures

Total operating expenditures for 2010 were estimated at close to \$3 billion (\$G), one-third of which represented wages. The latter, combined with supplier chain wages and remuneration, supported 27 349 direct, indirect and induced jobs. An industry's economic impact can also be determined by measuring its contribution to the gross domestic product (GDP). The direct, indirect and induced effects of the almost \$3 G in expenditures translates into a \$2.3 G contribution to the GDP at Québec market prices.

...of investment expenditures

Each year, the industry also invests significant amounts to restore its assets, replace them or acquire new ones. In 2010, \$459.1 M was earmarked for this purpose.

... of international cruise ships

While economic spinoffs from international cruise ships were not specifically analyzed in the context of this mandate, they were estimated by Tourisme Québec. The results show that cruise ship passengers and crew members spent \$36.6 M in 2010. This amount generated 378 jobs, contributed \$22.5 M to the GDP and brought the Québec government \$5.3 M and the federal government \$2.2 M.

Spinoff distribution by administrative region

One of SODES and the MTQ 's objectives was to identify the marine industry's economic contribution by region, as illustrated by the following table.

- A network of more than 20 ports and terminals serving all of Québec
- Economic spinoffs for all Québec regions
- 110 million tonnes of cargo transhipped annually on average
- 262 companies contributing \$2.3 billion to Québec's GDP
- More than 27,000 jobs generated on land and at sea
- \$1 billion paid in wages in 2010
- \$21 million spend on human resources training (2.1% of total payroll)
- \$681 million in revenues for governments
- 5.6 million passengers carried by ferries
- Investments of \$12.9 million in environmental technologies
- 116 300 cruise ship passengers who spend more than \$36 million during their stopover in Québec
